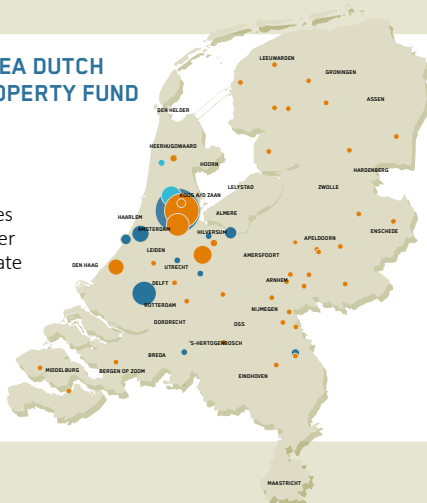

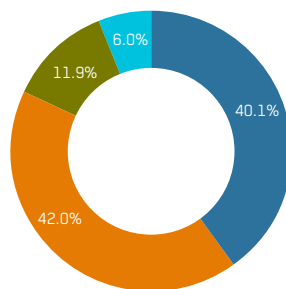

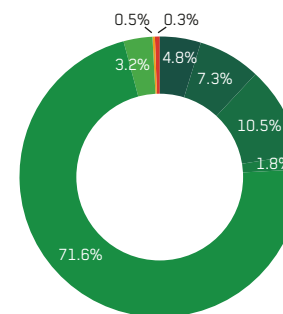


ALLOCATION TO SEGMENTS

The fund has a core risk/return profile. This is achieved by:

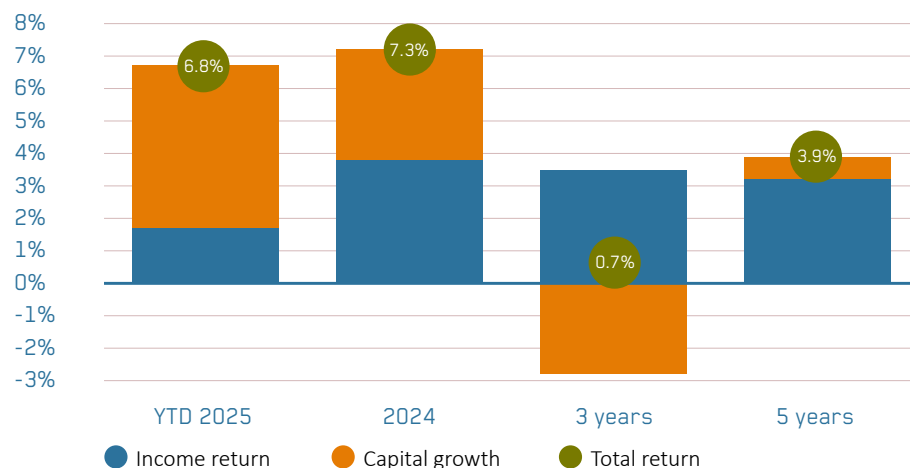
- Anticipating long-term trends relating to the ageing population, individualisation and market forces in healthcare.
